
#### New York Empire State Poll 2004

#### Objectives:

- Collect current workplace data on New Yorkers
- Provide a benchmark of New York State residents' views on a wide-range of issues: labor, economic, governmental
- •Support other research at Cornell University through omnibus modules
- Second ESP recently completed (May 2004)



### Respondents & Geography






### Rating New York State: 2003 vs. 2004

% of respondents who rate NYS in each category as good or excellent

Substantial increases in ratings of *education*, *environment*, and *economic growth*.

Ratings of *state budget*, *state taxes*, and *employment* are steady.





#### Rating New York State by Region

Upstate residents rate the state much higher in terms of *public education*, the *environment*, and *health & human services*.

However, downstate residents rate NYS much higher in terms of *economic growth*.

## Rating New York State by Annual Household Income

% of respondents who rate NYS in each category as good or excellent by annual household income

Ratings of NYS are relatively consistent across annual household income groupings, except in the areas of *public education* and *employment*.

## Rating New York State by Party Affiliation

% of respondents who rate NYS in each category as good or excellent by party affiliation

Republicans generally rate NYS much higher than Democrats or Independents, especially in the areas of *transportation*, *environment*, *education*, *and health* & human services.



### Most Important Problem in NYS: 2003 vs. 2004

Compared to 2003, state taxes and healthcare have become less salient.

Employment and the state economy continue to preoccupy New Yorkers' concerns.





## Most Important Problem in NYS by Region

**Employment** and the **state economy** are consistently strong concerns across regions. Largest regional differences are in terms of **state taxes** and **education**.



# Most Important Problem in NYS by Party Affiliation

Besides *employment*, substantial disagreement exists between Democrats and Republicans on priorities. In general, Independents are closer to Democrats than Republicans regarding priorities.



## Most Important Problem by Annual Household Income

**Employment** is the biggest concern of low and middle income respondents. Upper income households are less concerned about **employment** and more concerned about the **state economy**.



### Personal Economic Perceptions: 2003 vs. 2004

% of all respondents who said...

Fewer New Yorkers report doing financially worse over the past year. There is also a small increase in the number who reported doing better.



However, nearly a quarter of respondents still report they were financially worse off over the past year.

Overall, New Yorkers are more optimistic than last year, with an 11 point increase in the number of residents who believe that they will be financially better off in the forthcoming year.




## Personal Financial Situation by Region



Fewer upstate residents (17%) than downstate residents (25%) were financially worse off over the past year, yet downstate residents (46%) are more optimistic than upstate residents (39%).



## Personal Financial Situation by Race



Over the past year, substantially more non-white residents (28%) than white residents (19%) reported a worsening in their personal financial situation. However, non-white residents (54%) are substantially more optimistic regarding the forthcoming year than white residents (38%).



### State Economic Perceptions: 2003 vs. 2004

% of all respondents who said...

There is a substantial increase in the number of New Yorkers that perceive the NYS economy as doing the same or better in the past year.



Yet, a majority still perceive the economy as worsening rather than improving.

Mirroring personal optimism, the number of New Yorkers who believe that the state economy will improve in the forthcoming year has improved by ten percent.




## Perceptions of State Economy by Region



More downstate residents than upstate residents perceive the economy as improving over the last year, and downstate residents are more optimistic regarding the forthcoming year.



## Perceptions of State Economy by Party Affiliation



Nearly 60% of Democrats believe the economy has worsened compared to 40% of Republicans. Republicans are much more optimistic than Democrats regarding the forthcoming year as well. Overall, Independents mirror Democrats much more than Republicans.



The foremost issue mentioned by one-in-four ESP 2004 respondents was the *honesty and integrity* of the candidate, especially for Republicans (33%), but less so for Democrats (19%).




### Difficulty of Finding Jobs in Community: 2003 vs. 2004



Across NYS, the number of respondents reporting that finding jobs was harder over the past year substantially decreased in 2004. However, there was only a marginal increase in the number of New Yorkers that reported finding jobs was easier.




### Job Security by Category of Worker: 2003 vs. 2004



2004 found a marginal increase in overall level of job security among NYS workers. Downstate, hourly, non-white, and/or part-time workers have considerably less perceived job security than other categories of workers.




## Job Satisfaction in NYS: 2003 vs. 2004



Job Satisfaction has also increased, especially for upstate and union workers.




## NYS Workers' Benefits: 2003 vs. 2004



Child care subsidies or onsite care centers remain the least available benefit to New York State workers.



#### Likelihood of Joining a Union in 2004



53% of all workers in NYS would be somewhat or very likely to join a union if given a choice – over double the percentage of currently unionized workers.

The awareness of one-stop employment centers within NYS varies regionally, with almost twice as many employed upstate respondents (44%) aware of this employment resource as compared to only 24% of downstate respondents.





One third of ESP respondents reported being enrolled in some type of educational or training program within the last year with a weekly average of 14 hours of instruction.



### Living in the Same Community in 5 Years?






Approximately 75% of New Yorkers believe they will be living in their community in five years, though there are substantial differences between upstate and downstate residents. Younger residents are much more likely to move from their community.



#### Where are New Yorkers Going?



About half of the New Yorkers that are leaving their communities are leaving New York State, though a sizable portion of New Yorkers are still undecided. Older New Yorkers and members of middle or higher income households are more likely to leave NYS altogether compared to younger or lower income residents.



#### Local Community Satisfaction

Upstate respondents had higher levels of satisfaction on *safety/crime*, *public education*, *social and human services*, and *local government*. Conversely, downstate respondents were more satisfied than upstate respondents in the areas of *economic growth*, *employment*, and *cultural activities*.



### Indicators of Social Capital – Trust in NYS

Overall, upstate residents have much higher levels of trust than downstate residents, especially in *local businesses*, *local government*, and *other people*. Downstate residents are only more trusting when it comes to *labor unions*. Less than a third of New Yorkers trust *state government*.

NYS has comparable levels of civic volunteerism to the national average. Though a higher percentage of upstate respondents than downstate respondents reported volunteering with *child/youth development* organizations or organizations to help the *poor*, *sick*, *or elderly*.
